- The shares are held directly by Legion Capital, LLC ("Legion Capital"). Kyrus Holdings, Inc. ("Kyrus Holdings") is an entity that controls Legion Capital. Mr. Viscuso is a member of the board of directors and a stockholder of Kyrus Holdings. Mr. Viscuso disclaims beneficial ownership of all shares except to the extent of his pecuniary interest, if any, therein.
